#### **ELIGIBILITY:**

For admission in class-XI the following criteria will be considered:-

- For Non-Medical 88% Aggregate and Minimum of 90% in Science and Maths.
- For Medical 88% Aggregate and Minimum of 90% in Science and Maths.
- For Commerce 87% Aggregate.
- For Liberal Arts 87% Aggregate.
- Students only with standard Mathematics are eligible for Mathematics in classes XI
  & XII
- Those desiring Mathematics as an elective / optional subject must have atleast 87% in standard Mathematics.

### **SCHOLARSHIP:**

- \* Granted Freeship (one year)
- \*\* Full Tuition Fee Waiver
- \*\*\* Half Tuition Fee Waiver
  - Granting of Scholarship is subject to the candidate securing 92% in class X Board (CBSE) or equivalent and above in aggregate.
  - Students scoring 97% and above in the class-X CBSE Exam will be eligible for freeship for two years, irrespective of the stream opted for in class-XI.
  - Students scoring 96% and above but less than 97% in the class-X CBSE Exam will be eligible for freeship for one year, irrespective of the stream opted for in class-XI.
  - Students eligible for any kind of scholarship will receive the scholarship after declaration of the CBSE Board result and the scholarship amount will be deducted from the total fee to be paid for the session(2021-2022). If the scholarship amount exceeds the total fee to be paid for one session, the initial amount deposited will be refunded after the CBSE Board result.

#### FEES:-

Students who have been granted Provisional admission in any stream, will be required to deposit a sum of Rs. 40,000 online on the school portal on or before February 3,2021. The Link for the same will be sent on the registered mobile number.
