Subject to Scholarship Exam/ Board result

- Granting of Scholarship is subject to the candidate securing 90% in class X Board (CBSE) / equivalent (other boards) or above in aggregate.
- Students scoring 97% or above in the class-X Board (CBSE) / equivalent (other boards) will be eligible for freeship for two years , irrespective of the stream opted for in class-XI.
- Students scoring 96% or above but less than 97% in the class-X Board (CBSE) / equivalent (other boards) will be eligible for freeship for one year , irrespective of the stream opted for in class-XI.
- Students eligible for any kind of scholarship will receive the scholarship after declaration of the CBSE Board result and the scholarship amount will be deducted from the total fee to be paid for the session(2026-2027).If the scholarship amount exceeds the total fee to be paid for one session , the initial amount deposited will be refunded after the CBSE Board result.
- Two year freeship will continue in class XII subject to the condition that the student scores a minimum of 80% aggregate (in theory and practical separately in the five main subjects) in the class XI final result.

FEES :-

Students who have been granted Provisional admission in any stream , will be required to deposit a sum of Rs. 40,000 online on the School portal on or before March 31, 2026 . The link for the same will be sent on the registered mobile number.
